With reference to your application dated 24-07-2023 subsequent school inspection in this regard, I hereby convey the grant of Recognition to Mount Litera Zee School, Surat, Block no-218, Surat-Dandi road Road, Narthan patiya, Veluk, Ta-Olpad. District-Surat-395005. for **class I to XII** standard for the period of 3 years from the academic year 2023-24 to 2026-2027. in compliance to section 18 of Right of Children to Free and Compulsory Education, Act, 2009 & rule \_\_\_\_\_ of Gujarat Government.

The above recognition is subject to the following conditions: -

1. The temporary recognition accorded to the school is valid from the academic year 2023-24 to 2026-2027. and is to be renewed at an interval of every 3 years.
2. The grant of recognition is available initially for classes I to VIII standard and to be extended for Secondary /Senior Secondary classes subsequently in due course of time.
3. The school shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Compulsory Education Act 2009 of Gujarat Government.
4. The school shall admit in pre-school to the extent of 25% of the strength in each class, children

5. belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
6. The school shall maintain a separate bank account for the purpose of reimbursement.
7. The school shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
8. The school shall not deny admission to any child, -
  - a. For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
  - b. On the ground of religion, caste or race, place of birth or any of them.
9. The school shall ensure that, -
  - a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
  - b. No child shall be subjected to physical punishment or mental harassment.
  - c. No child is required to pass any board examination till the completion of elementary education.
  - d. Inclusion of students with disabilities/ special need as per provision of the Disability Act 2016 of Gujarat Government.
  - e. The teachers are recruited with minimum qualifications as laid under sub section 1 of section 23 of the Act or National Council of Teacher Education and state government authorized authority.
  - f. The teachers perform his duties specified under section 24 (1) of the Right of Children to Free and Compulsory Education Act – 2009
10. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
11. The school shall maintain the standards and norms as specified in Section 19.
12. No unrecognized classes shall run within the premises of the school or outside in the name of school.
13. The school building plan must have been approved by the current rules or G. Os. The school building or other structures and the grounds are used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respect are under whole responsibility of the managements.
14. The school is run by a society registered under the Society Registration Act 1860, or a public trust constituted under any law for the time being in force.
15. The school is not run for profit to any individual, group or association of individuals or any other persons.
16. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared.
17. The school shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.

- 17 English, Hindi, Gujarati, Sanskrit shall be taught as a subject from in standards I to X in all schools notified under Section 29(f) of Chapter V under Right to Education Act, 2009 from academic session recognition is granted.
18. The school shall have abided by the provisions of the Section 18 he Right of Children to Free and Compulsory Education Act, 2009
19. The certificates of recognition issued by the department shall be subject to the fulfillment of deficiencies if any pointed out by the department at any stage/ time.
20. The management shall rectify the deficiencies pointed out in infrastructure or administration by the authorities.
21. The management shall apply for renewal of recognition three months before the expiry of this order to this DEO, Surat.
22. The management shall follow the directions issued by the Government/ Department from time to time keeping in view of the safety and security of the children and the overall administration of the school.
23. The recognition shall be withdrawn if any contravention of the provisions of the Act, Rule or the conditions of recognition are found and proved.
24. The school management shall have to full responsibility if any court cases arises this regard. The management is not entitled to seek affiliation to other Board without obtaining NOC from the DEO, Surat.
