- **9.** It is submitted by Mr. Dawawala that, submitted that our school is not able to survive with this amount of fees, which has been ordered by your committee and requested to increase in it. They have also argued that last two order received by us with same amount of fees in standard 9<sup>th</sup>, 10<sup>th</sup> and 11-12 (Gen. and Sci.) which is unfair and unreasonable. Therefore we request your honor to reconsider all over fees as per standard level, please give us a good quantum or increment in upper standard level otherwise school will not survive and we will face huge difficulty.
